GENERAL RELEASE OF LIABILITY AND INDEMNIFICATION. *I hereby acknowledge that I have read and understand all contest rules as a participant in this event. Each team member hereby releases and agrees to indemnify and hold forever harmless, the Friends of Recreation and Parks, Wicomico County and the Wicomico County Department of Recreation, Parks, Tourism & Civic Center, its agents, officers and employees, against and from any and all claims, demands, actions, causes of actions, liability, losses, damages, expenses, costs, or judgments, including attorney's fees, punitive, consequential, statutory, direct and indirect damages, resulting from, or to result from, injury to or death of any person or damage to any property, of any kind, which injury, death or damage arises out of, or is in any way connected with, the member's participation in the event, or the receipt or use of any prize, or any of the released or indemnified party's acts or omissions in connection therewith (collectively a "Claim"), except to the extent arising from the sole negligence of the Friends of Recreation and Parks, Wicomico County, the Wicomico County Department of Recreation, Parks, Tourism & Civic Center, or its or their agents, officers and employees. I further agree that any Claim to which I might be entitled is limited to the cost of entering the event. I understand that no insurance covering accident, injury or damages has been provided for participants, and that arrangements for any such insurance would have to be made individually by the participant, and at no time will participation in the event be contingent on divulging any confidential medical information.*

CONTEST RULES

1. All prizes will be randomly drawn from eligible entries and will be awarded at the sole discretion of the event organizers (Friends of Recreation and Parks and the Wicomico County Department of Recreation, Parks, Tourism & Civic Center). Exchanges and/or refunds for party tickets are not permitted.
2. Each eligible team of participants is eligible for the "Fly Away" grand prize drawing. In addition, each eligible participant may win one other individual prize giveaway. Once an eligible participant has been selected as the winner of one other prize, that participant will no longer be eligible to win any other giveaway prizes with the exception of the Fly Away grand prize.
3. Individuals may register only once for the event and may only participate on one team. One ticket per person is required. Multiple registrations in the same name to increase chances of winning will be disqualified from the grand prize drawing.
4. The grand prize will be awarded at random to an eligible team. Team registration information may be completed in advance but can be changed up until check-in on the night of the party. Once eligible team members have checked in, no alterations to the team roster will be permitted.
5. The contest may be altered, cancelled or changed at any time by the event organizers.
6. By adding your email address to the WY&CC email database you agree to receive event and ticket information. You may opt out of this email database at any time. Your information will not be shared with or sold to third parties.
7. By participating in the contest, you agree that if you win the grand prize or any other prize then the Wicomico Civic Center and Wicomico County are granted the right to publicly use your name and image in promoting any and all future events or contests of the Wicomico Civic Center.
8. Only legal residents of the United States who are at least twenty-one (21) years of age are eligible to participate in the contest. Employees of the Department of Recreation, Parks, Tourism and Civic Center, board members of the Friends of Recreation & Parks as well as the immediate family (spouse, parents, siblings, and children) of each such employee or board member, are not eligible to enter.
9. Notification and requirements of potential winners: Winners will be announced at the Suitcase Party to be held on Friday, April 3, 2020. If a potential winner of the grand prize team is not present and/or does not present himself/herself at the party to event organizers within 15 seconds after the names of the team are selected and announced, then the team participants will forfeit the grand prize and a new team will be drawn. If a potential winner of another prize is not present and/or does not present himself/herself to the event organizer before the next scheduled drawing, then such participant will forfeit the prize and a new name will be drawn at the next scheduled drawing. Once a participant has forfeited a prize, the participant will not be eligible to win any subsequent prize given away at the party.
10. Prizes: The grand prize may not be transferred and must be accepted as awarded. A participant may not request cash or a substitute prize. The winning team or individual members of the team may not transfer their prize to another party-goer or outside individual. If any member of a selected team is not eligible, cannot meet the requirements for the contest as set out in the contest rules, is not present, or does not claim their prize in person at the party after being announced as the potential winners, then the participants of the selected team will forfeit the prize and a new team name will be drawn. **THE GRAND PRIZE CANNOT BE SOLD OR GIVEN AWAY.**
11. All prizes must be picked up by the selected participant(s) in person at the Suitcase Party at 500 Glen Ave., Salisbury, MD 21804 after their name is announced as a potential winner. Proper identification in

the form of a passport, driver's license, or other form of government-issued picture identification acceptable to the organizers may be required by the event organizers in order for a winner to claim a prize. All prize claims are subject to verification of the selected participant's eligibility.

12. As a condition of receiving a prize, the winner must sign and return any documents requested by the event organizers, including but not limited to an affidavit of eligibility, one or more liability releases and indemnifications, and a publicity authorization and release. The failure of either team member to sign and return any requested documents may result in disqualification of the selected team to win the grand prize and the forfeiture of all interest in the prize. Failure of a participant to sign and return any requested documents may result in disqualification of such participant to win a prize and the forfeiture of all interest in the prize.
13. If applicable by law, the winner will be issued an IRS FORM 1099 in the amount of the actual retail value of the prize and must provide event organizers with his/her valid Social Security Number or Taxpayer ID for tax reporting purposes. Payment of any and all applicable taxes is the sole responsibility of each winner.
14. Event organizers are not responsible for scheduling, cancellations, or performance by airline, hotel, or any other item or service associated with the prize. Additional rules and restrictions may apply.
15. Once the team members selected for the grand prize have complied with all eligibility requirements, the winning team will be escorted to their car(s) to retrieve their bags and will be transported immediately from the event to the Salisbury Airport to board a private jet bound for Atlanta, Georgia. The winners may not leave to go home and pack.
16. The grand prize includes the following:
 - a. Flight to Atlanta, Georgia on a private jet on Friday, April 3 for the winning team of two; return trip will be by coach air transportation arriving in Salisbury on Sunday, April 5.
 - b. Shuttle service transportation to and from the airports.
 - c. Hotel or lodging for the duration of the getaway, April 3-April 5, 2020 (one double occupancy room for both team members); no substitutions.
 - d. Two tickets to the NCAA Final Four basketball games to be held on Saturday, April 4, 2020.

The event organizers may provide other benefits at their discretion. The event organizers reserve the right to modify the grand prize, and if so, will announce the modifications at the event party.

The winning participants will be responsible to pay for all meals, food, and beverages, tips, bag fees, incidentals, and on-site transportation while in Atlanta.

17. Any trademarks, tradenames, and/or trade styles used in the event are the sole property of the respective owners of such trademarks, tradenames, and/or trade styles and they are used in connection with the event solely for identification purposes.
18. General Conditions: In the event that the operation, security, or administration of the event is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, event organizers may, in their sole discretion, either: (a) suspend the event to address the impairment and then resume the event in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize at random from among the eligible entries received up to the time of the impairment. Event organizer(s) reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the event or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the event may be a violation of criminal and civil law, and, should such an

attempt be made, event organizers also reserve the right to seek damages from any such person to the fullest extent permitted by law. Failure by event organizers to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to event organizers by mail shall not be deemed proof of receipt of that communication by event organizers. In the event of a dispute as to the owner of any entry, the entry will be deemed to have been made by the names listed on the registration form. The event is subject to all applicable laws and regulations and is void where prohibited.

19. Release and Limitations of Liability: Without limiting any other release or indemnification you execute in connection with the event, and in addition thereto, by participating in the contest, you agree to release and hold harmless event organizers, Friends of Recreation and Parks, Wicomico County, Wicomico County Department of Recreation, Parks, Tourism & Civic Center, and their respective parents, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (collectively the "Released Parties") from and against any claim or cause of action arising out of participation in the Event or receipt or use of any prize, including, but not limited to: (a) unauthorized human or other intervention in the event; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the event or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the event or receipt or use of any prize. You further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering the event, and in no event shall the Released Parties be liable for attorney's fees. You waive the right to claim any punitive, consequential, statutory, direct, or indirect damages. Disputes: You agree that any and all disputes, claims and causes of action arising out of, or connected with, the event or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Maryland. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of the event organizers in connection with the event, shall be governed by, and construed in accordance with, the laws of Maryland, without giving effect to any choice of law or conflict of law rules (whether of Maryland or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Maryland. All issues and questions concerning the construction, interpretation or application of the official rules shall be made by the event organizers, in their sole discretion.
